






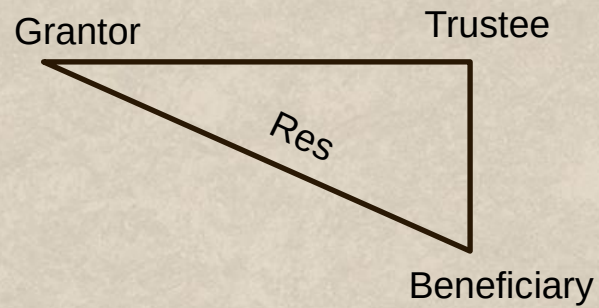

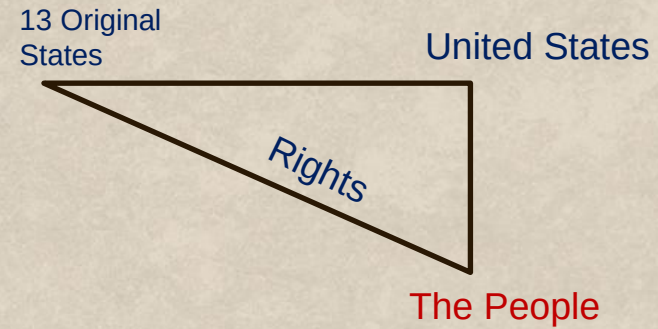

The United States is a Trust

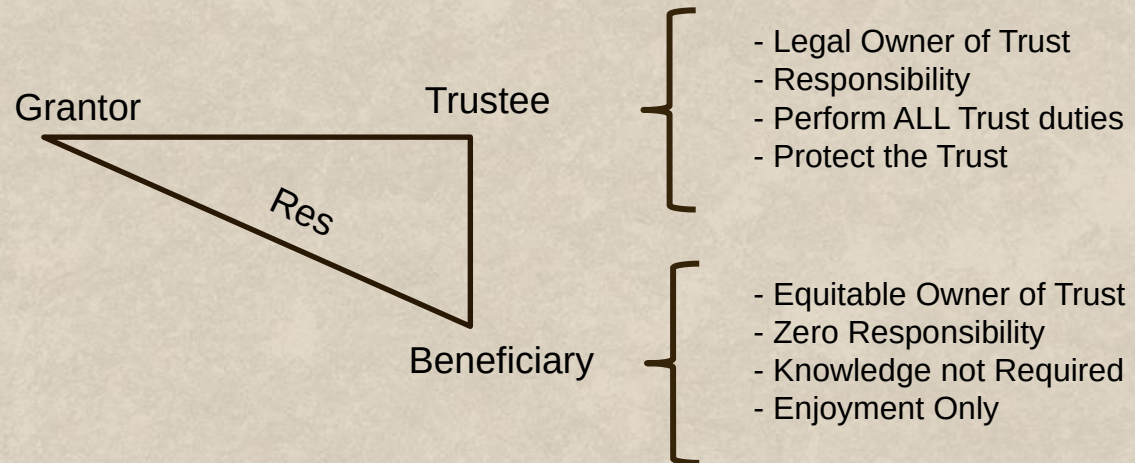


Basic parties/titles of a trust

Basics of Trusts



A trust separates ownership between the Trustee and Beneficiary. The Trustee has legal ownership and an obligation to perform. The Beneficiary has equitable ownership and no duties. This dynamic prevents any obligations of ownership, as nobody has full ownership or control.

In Common Law & Equity, “-the rule of **doing to all others as we desire them to do to us**; or, as it is expressed by Justinian, “**to live honestly, to harm nobody, to render to every man his due.**”

People shall be secure in their Persons



Our nation is being controlled by those who don't see humanity, who don't see other living souls, who see people as objects and have no connection to us at all. They are deceitful and ruthless and take full advantage of living people who have compassion and care about what is right. They have no excuse for their actions and behavior, except that they can get away with it. Calling them out, forcing them into the light exposes their treachery.

I've heard the word 'sin' be described not as acts and deeds, but rather being separated from your authentic self. The outside you not being the same as the inside you. It doesn't have to be the US citizen you're 'wearing', it can be any other character you're trying to be for approval of the crowd that is different from the authentic you.

What can we do?

How do we stand up?

1. Unregister to vote and end other contracts swearing or affirming to be a citizen of the United States.

2. Private Express Trust: Your very own creation and entity insulated from presumed commercial & statutory contracts. FEE SCHEDULE

3. Notice of Liability, Common Law process, file common law claims against government actors.

Any duty or obligation without and expressed contract is a violation of the 4th amendment.

1. persons can be, and are almost universally artificial, which allows the United States and it's subsidiaries to presume jurisdiction.
2. the government makes contracts and creates obligations for persons all the time.
3. the only obligation that can be enforce onto a man or woman is thru a lawful and mutually executed contract.
4. without a mutually executed and lawful contract, enforcing an obligation for persons onto people is a violation of the 4th Amendment to the United States constitution & Article II, Section 7 of the Colorado Revised Statutes.
